



PRELIMINARY REPORT

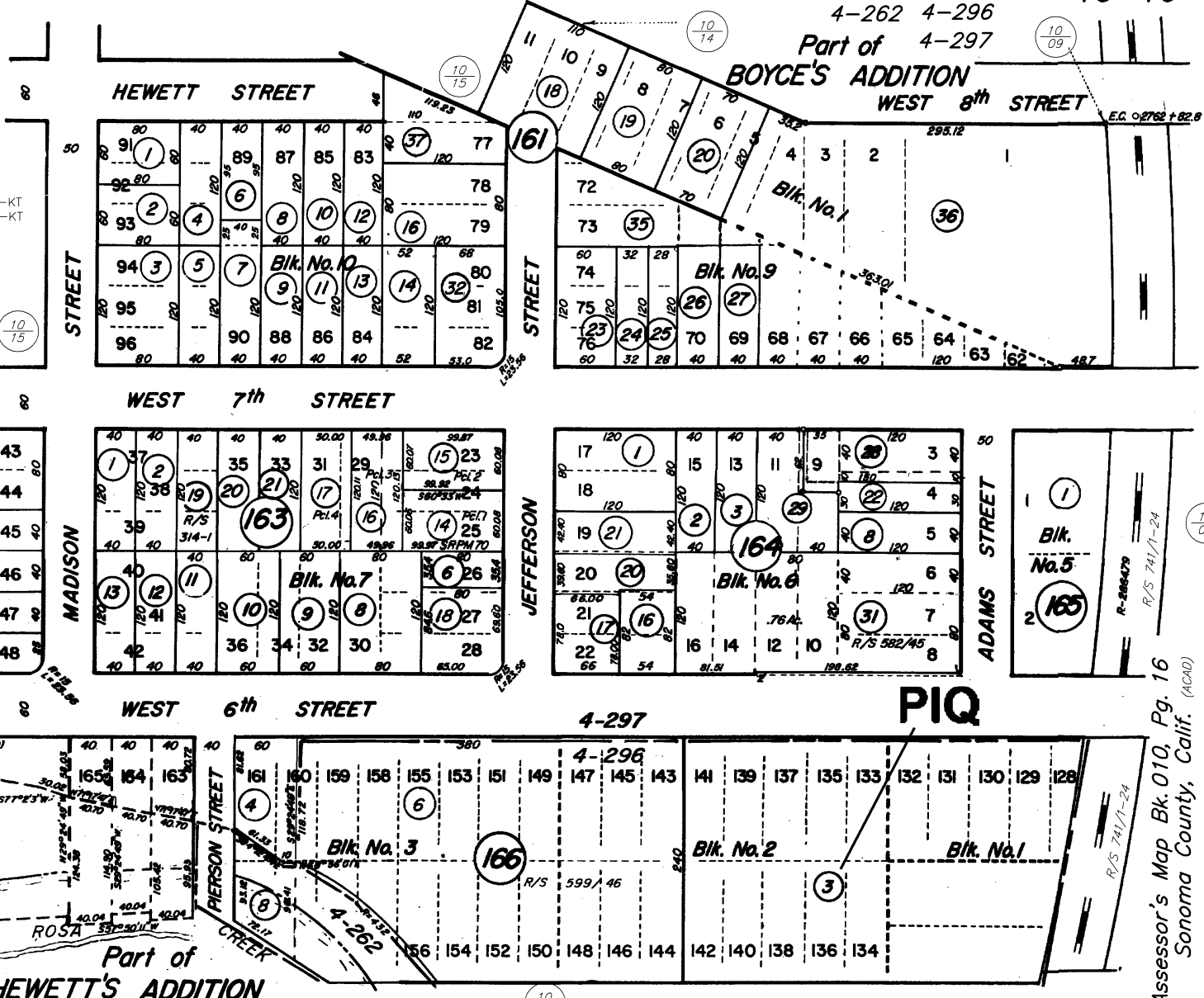
