#### **Community Outreach | Programs**

In November, SMART began participating in the Clipper START program, joining the collection of ten Bay Area Transit agencies offering discounts to low-income riders. Clipper START is an 18- month pilot program, started by the Metropolitan Transportation Commission and Bay Area transit agencies using the Clipper fare collection system. Bay Area residents age 19-64 who meet certain income requirements that are 200% of the federal poverty level or less are eligible to participate in the program. Eligible riders can apply to participate in the Clipper START program online at www.clipperstartcard.com. Applicants must provide proof of identity and income, such as a copy of an Electronic Benefits Transfer card or Medi-Cal card, a county benefits eligibility letter, or a copy of their last federal tax return to demonstrate their eligibility. Once approved by Clipper, they will receive a personalized Clipper card that must be loaded with cash value before use. Clipper START participants receive a 50% discount on single ride fares on SMART. The discount will automatically be applied to participating transit agency fares with the Clipper START card. ### MAINTENANCE OF WAY:

- Signal team repaired crossing gate knock down due to large truck collision at Washington Street in Petaluma

### VEHICLE MAINTENANCE:

- Performed inspection on Diesel Multiple Unit 105 due to faults occurring causing the Diesel Multiple Unit to not exceed 10 mph. Upon further investigation it was determined that the master controller had drifted out of range. The master controller was changed out and the Diesel Multiple Unit was placed back into service
- Performed overhaul brake maintenance on Diesel Multiple Unit 105. This maintenance involves removing all brake components and sending them out to a third party to have them inspected and certified. This maintenance allows SMART to stay in compliance with Federal Railroad Administration's requirements
- Performed mid-year maintenance on 2 Diesel Multiple Unit
- Performed 500- hour oil change on 3 Diesel Multiple Units
- Automatic Train Control maintenance performed on 7 Diesel Multiple Units. This maintenance keeps us compliant with Federal Regulatory Association regulations in regards to positive train control
- Performed data downloads on the fleet. The Diesel Multiple Units have many subsystems that are integrated. Downloading the systems data provides SMART an opportunity to investigate different occurrences that may not show during our normal inspections
- Performed emergency exit window pull test on 10 of the Diesel Multiple Units. The test is to
  establish confidence per the Code of Federal Regulations that the emergency exit windows
  will react as designed during an emergency
- Performed deep cleaning on the fleet light covers and seats
- Performed Automatic Train Control inspection on Northwestern Pacific Railroad engine 2009
- Removed Heating Ventilation Air Conditioning filters throughout the fleet and installed new Minimum Efficiency Reporting Value filter's (MERV-13)

### FREIGHT SERVICE

At the November 18, 2020 Board Meeting, I provided an update on the status of Freight Service and related activities. The Board approved a number of policies establishing SMART to become a Freight Service provider. The following activities have taken place and are ongoing:

- The State of California has been funded the \$4M for the purchase. The funds have been encumbered and deposited into an escrow account;
- The State of California has funded the \$2 million for SMART for freight maintenance. The funds have been encumbered and deposited into an escrow account;

SMART has not spent any agency funds to purchase NWPCo. All the funds are from the State of California and deposited into an escrow account.

The following two Agreements are pending and are near execution: 1) The Asset Transfer Purchase Agreement between SMART and NWPCo. This agreement is for SMART to purchase the assets once the funds are received; and 2) The Baseline Agreement between the State of California and SMART has been finalized and is pending execution.

### Property Acquisitions (in process)

*Downtown Petaluma Station Property:* Staff has finalized a fiber optics easement to Union Pacific Railroad on the property. The developer has paid a fee to Union Pacific and staff has recorded the easement November 24, 2020. Staff is continuing to work with the City of Petaluma on the new entrance to the station parking lot.

*Windsor Extension Project:* Staff is continuing to research property rights that were granted to third parties on or along the new extension. Staff is continuing to work with utility companies on a variety of tasks on the new extension property.

*North Coast Rail Authority (NCRA):* Staff is continuing research on the real property assets that will be transferred if the agreement is approved by all the authorizing agencies.

### **GRANTS, LEGISLATION, PLANNING AND REGIONAL ACTIVITIES**

### REGIONAL AND LOCAL LANNING ACTIVITIES

*Local Planning Department Notification and Coordination Tracking:* Staff also tracks and reviews all notices sent by local jurisdictions for projects occurring adjacent to or nearby the railroad tracks. In 2019 staff received and reviewed 171 different notices, with 160 notices by the end of November 2019. To date in 2020, SMART has received and reviewed <u>102</u> different notices.

State Route 37 – Caltrans Planning and Environmental Linkages Study (Sr37 Pel Study): Caltrans is beginning a State Route 37 Planning and Environmental Linkages Study (SR37 PEL), commencing with a series of Stakeholder meetings to educate on the purpose, process and outcomes of a PEL study. SMART staff participated in a stakeholder meeting on November 16, an online survey November 24, and an in person interview the first week of December. The PEL study will gather preliminary data, consider the conceptual level of design, traffic analyses, and evaluation of environmental impacts, and result in recommendations for the corridor.

*Bay Area Healthy Transit Plan:* SMART participates in coordination meetings related to the Bay Area Healthy Transit Plan with a meeting on November 12. ### SYSTEM ACCESS PLANNING ACTIVITIES

*Clipper START (Low-Income Transit Fare) Pilot Program:* The Metropolitan Transportation Commission (MTC) has launched a low-income transit fare pilot program on select Bay Area transit systems, including a November 23 launch on SMART, Santa Rosa CityBus, Petaluma Transit, Sonoma County Transit and Marin Transit as they join Golden Gate Transit and Ferry in offering discounts for income-qualified passengers.

SMART, Golden Gate and Marin offer 50% off adult single ride fares, with Santa Rosa, Sonoma County and Petaluma offering 20% off. The program allows adults who live in the Bay Area and whose annual earnings are up to 200 percent of the federal poverty level to qualify for fare discounts. The Clipper START pilot <u>requires riders to use Clipper</u> for fare payment. Riders can apply online or by submitting a paper application. Applicants will need to provide proof of identity and proof of income, and those approved will receive a personalized Clipper card that can be used for single-ride discounts on the participating transit agencies' systems. Transit Coordination Meetings:

- November 4, 2020 Staff participated in the Metropolitan Transportation Commission (MTC) monthly Transit Finance Working Group meeting. Discussions included several standing item updates: legislative updates, funding notices, Transportation Improvement Program update, Cap and Trade Update, Regional Transit Capital Priorities process, and COVID-19 Response.

### **GRANTS**

State of California Short Line Railroad Improvement Program: Caltrans has submitted an application to the California Transportation Commission requesting \$1.5 million in funding from this one-time Statewide competitive program. Only \$7 million in funds are available to "Short Line" Railroad properties for improvements to advance the movement of freight traffic onto the rail network and off of the road network. The Metropolitan Transportation Commission has written a letter of support for this request. The CTC is expected to announce the programming of the funds in January 2021.
